

**TENTH JUDICIAL DISTRICT NOMINATING COMMISSION
DISTRICT MAGISTRATE JUDGE POSITION**

The 10^h Judicial District Nominating Commission is seeking nominees to fill a district magistrate judge position in Johnson County. Statutes require a district magistrate judge to be a graduate of a high school or secondary school or the equivalent; to be a resident of Johnson County at the time of taking the oath of office and maintain residency in Johnson County while holding such office; and to either be a lawyer admitted to the practice law in Kansas or to pass an examination given by the Supreme Court and to become certified within 18 months, as provided by K.S.A. 20-334(b) and K.S.A. 20-337.

The following questions must be answered on by an applicant 8 1/2 by 11 paper. State the question, as it is written, then give the answer. Any answers are subject to disclosure and may be discussed during the interview process, which is open to the public. Required documents: original and 15 copies each of (1) this completed application; (2) a **maximum** of 5 supporting letters; (3) a writing sample; and, if applicable, (4) a copy of your continuing legal education reports (MCLE Annual Report) for the past three years (see, www.ksdle.org). These documents must be delivered to the Commission Secretary listed at the bottom of this form no later **NOON June 21, 2023. One original of the Authorization for Release must be provided.** It should be attached separately in a sealed envelope.

If you are asked to provide the name of an attorney or judge, please include the **person's name, address, zip code, phone, and e-mail.** Applicants are encouraged, but not required, to provide a photograph with their application.

14. Are you a director or officer of any business, corporation, partnership or joint venture? Do you hold an ownership interest of more than \$5,000 in value (stock, partnership or proprietorship equity, or otherwise) in any business or corporation? Is there any such connection that you would not be willing to sever if the relationship resulted in your frequent disqualification?
15. Have you ever been sued? If so, give particulars, including case numbers.
16. Have you ever been a party in any other legal proceeding? If so, give the particulars. Include all legal proceedings in which you were a party in interest, including divorce proceedings; a material witness; a named co-conspirator or co-respondent; and any grand jury investigation in which you figured as a subject, or in which you appeared as a witness. Do not list proceedings in which you were sued only in a representative capacity (e.g., guardian *ad litem*).
17. Have you ever been the subject of an order or other discipline imposed by a professional disciplinary body, or found in contempt? Identify the body or court involved.
18. Do you have a professional, business, family or personal relationship with any member of the Judicial Nominating Commission to whom you are submitting this application? If so, provide a description of this relationship.
